In this context, the European Commission has just published its Reflection paper on harnessing globalisation - the second of five reflection papers announced in the White paper on the future of Europe. Its aim is to launch a debate on how the EU and its Member States can shape globalisation in a way that anticipates the future and improves the lives of Europeans.
