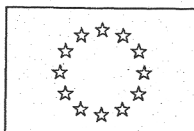

Notice of call for expressions of interest

1. Contracting authority

2. Type of notice:

Call for expressions of interest.

Persons interested are invited to submit an application in accordance with the rules set out in this notice for the purpose specified. Candidates can be individual persons, public or private organizations, consortia or groupings of suppliers.

The contracting authority will draw up a list of candidates who meet the criteria set out at point 8 below. This list comprises sub-lists, corresponding to each of the fields described in point 4.

Each time a specific contract is to be concluded relating to the field described at point 4, the contracting authority will invite all the candidates on the list on the relevant sub-list(s) or some of them, selected on the basis of objective and non-discriminatory criteria, to submit a tender.

Should the contracting authority have to set a maximum number of candidates who will be invited to submit a tender for a given contract, the maximum number is 20. The contracting authority will send the candidates invited to submit a tender the call for tenders relating to the contract in question.

Inclusion on the list entails no obligation on the part of the Commission concerning the award of the contract nor, in view of the preceding paragraph, concerning an invitation to tender.

If processing your reply to the invitation to tender involves the recording and processing of personal data (such as your name, address and CV), such data will be processed pursuant to Regulation (EC) No 45/2001 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data. Unless indicated otherwise, your replies to the questions and any personal data requested are required to evaluate your tender in accordance with the specifications of the invitation to tender and will be processed solely for that purpose by Mr. Stephan Lechner, Director of the Institute for the Protection and Security of the Citizen. 4. Full description of the fields covered by the call for expressions of interest.

The European Laboratory for Structural Assessment (ELSA) of the JRC-Ispra is equipped with a large reaction-wall facility and has acquired its best expertise on the development and implementation of innovative experimental techniques mainly related to testing large-scale civil structures by means of the pseudo-dynamic method. These tests require the construction of huge mechanical set-ups equipped with powerful servohydraulic and electric actuators and advanced instrumentation.

The materials and equipment needed in this installation are divided into 6 fields:

Field 1: mechanical components:

Raw materials: steel plates, steel sheets, steel bars, steel tubes and steel profiles.

High strength high alloy steel: rods and threaded bars.

Fasteners: high strength bolts, springs, belleville and safety washers, cylindrical and taper pins, circlips and shim rings.

Rolling and plain bearings: radial ball and roller bearings, axial ball and roller bearings, bearing housings, spherical plain bearings, rod ends, plain bushes, rolling platforms.

Linear guidance systems: linear ball bearings, linear roller bearings, linear tables, ball screw drives.

Gears, couplings, clutch, belts and pulleys.

Workshop tools and accessories: cutting, tightening and clamping tools, measuring instruments and metrology, abrasives and saws, hand tools, workshop accessories.

Workstation and storage, ecological systems for solid and liquid storage material.

Specific mechanical devices made according to specifications and drawings provided by the JRC.

Field 2: safety devices and equipment:

Personal protective devices and equipment (are defined as those devices and equipment designed and utilized for the protection of a single individual and are worn or attached to the individual): safety headgear, eye and face protection, hearing protection, limb and body protection, flame-resistant clothing, and protective clothing and equipment for workers involved in welding or burning operations or cutting and allied processes, respiratory protection, personal fall-protection system.

Lifesaving devices and equipment (are those devices and equipment provided for the protection of 1 or more individuals at any given time): fall protection, safety barriers, safety parapets, guardrails, signaling tapes and chains. Protection from falling materials. Anchorage systems: mechanical and adhesive anchoring systems, cement. Absorbent material oil/water.

Field 3: electronic/electric components:

Discrete and integrated active components, passive components (RLC), switches and commutations, relays, electromechanical components, accumulators, transformers, power supplies, continuity group, printed circuit boards, displays and optoelectronic components, connectors, cables, extension cords, extension reels, power strips, industrial PCs components and electronic boards (PCI, ePCI, ATbus, PC104, ETX ...), racks and containers, electric motors and linear actuation systems, piezo actuation systems, electrodynamic shakers, fans, chemical cleaning products, wireless, radio modem, microprocessor components and development kits, FPGA and CPLD components and development kits. Precision hand tools (cutters, pliers, tweezers, screwdrivers, drill ...), welding tools, precision electrical tools. Industrial video and display systems.

Field 4: high-pressure hydraulic components:

High-pressure hoses and tubes, quick release coupling, valves (ball valves, on/off valves, proportional valves), servovalves, bladder accumulators, flanges, pumps and power units, servocylinders, filtration, fluid connectors, hydraulic fittings, tube clamps, manifolds, hydraulic fluids (oil), seals (o-rings, piston seals, rod seals, wear rings, scrapers). Nitrogen boosters. Specific hydraulic devices made according to specifications and drawings provided by the JRC.

Field 5: measurement transducers and electronic instrumentation:

Transducers: displacement, velocity, acceleration, temperature, humidity, pressure, strain gauges, inclinometers, load cells, optic, sonic and ultrasonic, magnetic.

Instrumentation: multimeters, photometers, counters, LCR, oscilloscopes, signal generators, amplifiers, logic analysers, spectral analysers, loggers, front-end and data acquisition systems, PLC, servo-controllers, infrared camera. Specific instrumentation and electronic interfaces made according to specifications and drawings provided by the JRC.

Field 6: Multimedia, digital photography and video:

Photo digital camera, video digital camera, video data acquisition, image processing, objectives, illumination and flash, support kits, photometers, video monitor and screen, video connectors and cables, related accessories.

5. Place of delivery:

6. Expiry date of the list resulting from this call for expressions of interest:

The list of potential suppliers will remain valid for 3 years from the date of dispatch of this notice to the Publications Office of the European Union (OP).

Interested parties may submit an application at any time prior to the last three months of validity of the list.

7. Legal form of the group awarded the contract:

No special legal form is required from applicants. However, groupings may, irrespective of their legal form, submit a tender, provided each participant satisfies the requirements. Candidates who have formed a grouping may submit a joint tender. Members of the grouping are to designate the party to act as sole representative, on their behalf, vis-à-vis the Commission.

8. Criteria for inclusion in the list of potential contractors:

8.1 Exclusion criteria

To be eligible for participation in this call for expressions of interest, applicants must not be in any of the exclusion situations referred to in Articles 93 and 94 of Council Regulation No 1605/2002 of 25.06.2002 OJ L 248 of 16.09.2002 and are required to submit the documents mentioned in article 134 of the Commission Regulation 2342/2002 of 23.12.2002 of OJ L 357/1, as last modified by Commission Regulation 478/2007 of 23.04.2007 of OJ L 111/3 of 28.04.2007.

According to these provisions candidates are required to submit a declaration of honor that they are in none of the situations referred to in Articles 93 and 94 FR. The template of declaration of honor is available on the website referred to below in Section 11 "Other information".

8.2 Selection criteria

The purpose of these criteria is to determine whether a supplier has the necessary **economic, financial, technical and professional capacity** to supply items specified under point 4. Candidates who are not considered to have the required capacity will not be included on the list of suppliers.

Economic and financial capacity

- a) a statement of overall turnover and turnover concerning the supplies covered by this call for expression of interest during the last financial year.

Technical and professional capacity

- b) a list of the principal supplies provided in the past two years, with the sums, dates and recipients, public or private; in particular all Contracts with the European Commission.

In case of groups of candidates submitting an application, all members of such groups have to provide the relevant documents concerning the criteria stated in point 8. The information concerning the economic and financial capacity as well as the technical and professional capacity is analysed as a whole for these groups and in connection with the role proposed for each member of the groups.

9. Full list of information, formalities and documents to be provided by interested parties:

To apply, any candidate shall:

- prove that he is authorised to deliver the supplies under national law, as evidenced by inclusion in a trade or professional register, or a sworn declaration or certificate, membership of a specific organisation, express authorisation, or entry in the VAT register,
- provide the documents required in point 8.2(a) and (b) above,
- complete and sign a declaration of honour with respect to the exclusion criteria and absence of conflict of interest as indicated in point 8.1 above. The template of declaration of honour is available on the website referred to below in Section 11 'Other information'.
