THE STRATEGY FOR THE RIGHTS OF PERSONS WITH DISABILITIES

Around 87 million people live with some form of disability in the EU.

Yet, despite progress in many areas, persons with disabilities still face considerable barriers in access to healthcare, education, employment, leisure activities and participation in political life.

The **Together for Rights** campaign promotes a genuine **Union of Equality** where all persons with disabilities enjoy their rights and live as equals.



Our goal is to improve the quality of life of persons with disabilities in the EU and beyond. We must ensure their rights, an important pillar in the process towards a Union of equality.

28.4% of persons with disabilities are at risk of poverty and social exclusion compared to

4x more

WHAT IS THE EU DOING TO HELP PERSONS WITH DISABILITIES?

In March 2021, the European Commission adopted the Strategy for the Rights of Persons with Disabilities 2021 to 2030. It aims to ensure that all persons with disabilities;

Can make full use of their human rights.

• Have equal opportunities and equal access to participate in society and the economy.

- Can decide where, how and with whom they live.
- Can move freely in the EU.
- Are no longer victims of discrimination.

The strategy will bring positive changes to the lives of persons with disabilities, for example:

• A proposal for a **European Disability Card** for all EU countries by the end of 2023. The card will facilitate the free movement of persons with disabilities, making it easier for them to access services wherever they are in the EU.

 The creation of a European Resource Centre (AccessibleEU) to allow European countries to work together to make things more accessible for persons with disabilities.

This strategy is the EU framework for actions to create a more equal society. It contains concrete actions to make sure persons with disabilities can enjoy their rights. The European Commission cannot achieve this alone; it requires commitment from all countries and support from all of us. Importantly, change will only come if we involve those directly affected, persons with disabilities.

The EU and all its member countries have signed the United Nations Convention on the Rights of Persons with Disabilities. It means that every EU country must protect the rights of persons with disabilities.

We must work together to make sure persons with disabilities enjoy equal rights and opportunities.

ABOUT THE CAMPAIGN

The Together for Rights initiative was developed in consultation with advocates from European disability organisations and their members.

It will be rolled out online until March 2023 in partnership with 27 citizens ('Champions') from across Europe who live with different disabilities.

The campaign is organised around six themes that address separate issues related to disability rights.
